

COMPLIANCE STATEMENT REGARDING STRUCTURAL FIREFIGHTING PROTECTIVE HOODS MANUFACTURED BY MAJESTIC FIRE APPAREL, INC.

Majestic Fire Apparel, Inc.'s personal protective equipment (PPE) products are designed with overall quality, end-user safety, and environmental considerations in mind. Our products are manufactured to meet the requirements outlined in the NFPA 1971-2018 Standard on Protective Ensembles for Structural Fire Fighting. They are further supported by an effective system of quality management controls, which includes procedures for reviewing raw material and utilizing test data from third parties to support our compliance with the NFPA Standard.

Based on information from our suppliers, we make the following statements regarding our Structural Firefighting Hoods.

Disclosure for Use of PFAS in Majestic Fire Apparel, Inc. Products

Majestic Fire Apparel, Inc. does not alter, add, or utilize PFAS chemicals in our assembly processes for the manufacturing of structural firefighting protective hoods.

We purchase barrier fabrics from textile manufacturers for incorporation into our structural firefighting particulate-blocking protective hoods only.

Based on the information provided by our barrier fabric suppliers, these fabrics contain polymer compounds, with some fabrics also including durable water-repellent finishes, which fall under the definition of PFAS chemicals.

These polymer compounds and finishes are critical to firefighter safety and aid in reducing firefighters' risk from extremely dangerous exposures.

This includes providing limited protection from firefighter exposure to fireground particulates and the absorption of oily chemicals, while also reducing heat stress.

We further utilize these barrier fabrics to meet the particulate blocking and total heat loss criteria mandated by NFPA 1971-2018 for structural firefighting particulate-blocking hoods.

Majestic Fire Apparel, Inc. is working towards the certification of its products to the 2025 edition of NFPA 1970, *Standard on Protective Ensembles for Structural and Proximity Firefighting, Work Apparel, Open-Circuit Self-Contained Breathing Apparatus (SCBA) for Emergency Services, and Personal Alert Safety Systems (PASS)*, which replaces the current NFPA 1971-2018 standard.

As part of the new requirements, Majestic Fire Apparel, Inc. will be required to have its protective hood materials evaluated for a range of restricted substances, including PFAS chemicals. For products that do not contain PFAS, NFPA 1970 will permit an additional labeling claim related to minimum levels of PFAS at 100 ppm for base materials.

The NFPA 1970 non-PFAS level of 100 ppm or less is commensurate with the new California regulations found in California's Safer Clothes and Textiles Act (AB 1817), although this bill currently excludes PPE from the requirements.

California Proposition 65

Majestic Fire Apparel, Inc. does not alter the inherent chemical properties of any fabric used in our assembly processes for the manufacturing of structural firefighting hoods.

We purchase various fabrics from textile manufacturers for incorporation into our structural firefighting hoods.

Based on information received from our suppliers, our products may contain a chemical known by the state of California to cause cancer, birth defects, or other reproductive harm.
