To our valued customers,

Majestic Fire Apparel, Inc. is providing this letter in regards to the new California Proposition 65 regulations that went into effect August 30, 2018. California Proposition 65 (PROP 65) is a California law which has been in effect since 1986. The goal of PROP 65 is to promote clean drinking water and to keep toxic substances out of consumer goods. PROP 65 requires warnings about exposures to certain chemicals that the State of California has determined to cause cancer, birth defects, or other reproductive harm.

CA PROP 65 requires a warning label on any product that is known to contain or may contain any of the more than 800 elements that the California Air Resources Board considers harmful. The warning does not mean that these products will necessarily cause cancer or reproductive harm. A PROP 65 warning does not mean a product is in violation of any safety standard or requirement. The California government has further clarified that “the fact that a product bears a Proposition 65 warning does not mean by itself that the product is unsafe.” The CA government has also explained that “You could think of Proposition 65 more as a ‘right to know’ law than a pure product safety law.”

Based on information received from our suppliers, our products may contain a chemical known to the state of California to cause cancer, birth defects, or other reproductive harm. Majestic Fire Apparel, Inc. does not alter the inherent chemical properties of any raw materials during our manufacturing process. We convert various fabrics and raw materials into PPE.

Since Majestic Fire Apparel, Inc. products are sold through dealers, we have no way of knowing where our products might eventually be sold. Therefore, we will be labeling all of our products in compliance with PROP 65 out of an abundance of caution. We have created a PROP 65 WARNING LABEL that will be attached to each bag for products we produce starting August 31, 2018.

We know that many of our dealers carry inventory that does not have the warning label needed. Therefore, we have created a download on our website at [www.majhoods.com/prop65](http://www.majhoods.com/prop65). With the download, you can print the PROP 65 WARNING LABEL at your convenience. The PROP 65 WARNING LABEL should be used with the sales of our products within the state of California. Please affix the PROP 65 WARNING LABEL to the outside bag / packaging of our products.
